- ✓ You were born before January 1, 1998
- ✓ You were married as of the date you filed your original FAFSA for 2021-2022.
- ✓ You are enrolled in a masters or doctorate program (such as an MA, MBA, MD, JD, PhD, EdD, graduate certificate, etc.)
- ✓ You are currently serving on active duty in the U.S. Armed Forces for purposes other than training.
- ✓ You are a veteran of the U.S. Armed Forces
- ✓ You have children who will receive more than half of their support from you between July 1, 2021 and June 30, 2022.

- ✓ At any time on or after July 1, 2020, your high school district homeless liaison determined that you were an unaccompanied youth who was homeless.
- ✓ At any time on or after July 1, 2020 the director of an emergency shelter or transitional housing program funded by the U.S. Department of Housing and urban Development determined that you were an unaccompanied youth who was homeless.
- ✓ At any time after July 1, 2020 the director of a runaway or homeless youth basic center or transitional living program determined that you were an unaccompanied youth who was homeless or were self-supporting and at risk of being homeless.

By Federal Law the following conditions are <u>not acceptable</u> for consideration for a Dependency Status Override:

- ✓ Parent's refusal to contribute financially to a student's education or provide data for the FAFSA.
- ✓ Parent's refusal to claim a student as a tax exemption
- ✓ Student's demonstrated self-sufficiency and/or living one one's own.
